The cigarettes segment consists of filter cigarettes and plain cigarettes. The cigars and cigarillos segment comprises large cigars and small cigars. Similarly, the smokeless tobacco segment consists of pipe tobacco and fine cut tobacco (FCT) and the smoking tobacco segment includes snuff/snus and chewing tobacco products. The market is valued according to retail selling price (RSP) and includes any applicable taxes.
- The Indian Tobacco & Tobacco Products market had total revenues of \$19,297.6 million in 2022, representing a compound annual growth rate (CAGR) of 13.2% between 2017 and 2022.
- Market consumption volumes declined with a CAGR of -0.6% between 2017 and 2022, to reach a total of 80,807.1 million units in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 3.1% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$22,508.8 million by the end of 2027.
