- The Indonesian telecommunication services market had total revenues of \$12.9 billion in 2022, representing a compound annual growth rate (CAGR) of negative 0.8% between 2017 and 2022.
- Market consumption volumes declined with a CAGR of negative 1.5% between 2017 and 2022, to reach a total of 424 million total subscriptions in 2022.
- Indonesia's share in the telecommunication services market in the Asia-Pacific market stood at 1.9% in 2022. The growth in 2022 is attributed to the growing proportion of internet users and the increasing mobile subscriber penetration rate.
