Both unbranded generics and branded generics are included in our market scope. However, off-patent drugs that continue to be offered by the original manufacturer under the original name, and which form part of the 'generic-eligible' market, are not included. The market value is evaluated at ex-factory prices.
- The Japanese generics market had total revenues of \$15.0 billion in 2022, representing a compound annual growth rate (CAGR) of 14.3% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 7% between 2017 and 2022, to reach a total of 56.4% in 2022.
- The mounting aging population in the country is boosting healthcare costs, as a result, the Ministry of Health, Labor, and Welfare (MHLW) promotes the usage of generic drugs as these are much more affordable.
