growth rate (CAGR) of negative 6% between 2017 and 2022.

- Market consumption volume increased with a CAGR of 1.3% between 2017 and 2022, to reach a total of 13.6 million total subscriptions in 2022.

- Singapore's share in the Asia-Pacific telecommunication services market stood at 0.4% in 2022. The growth in 2022 is attributed to the growing proportion of internet users and the increasing mobile subscriber penetration rate.
