- The systems & ordnance segment accounted for market's the largest proportion in 2022, with total revenues of \$1.0 billion, equivalent to 48.4% of the market's overall value.
- According to in-house research, in 2022, Finland accounted for a share of 2.1% in the European aerospace and defense market. The notable growth is driven primarily by the fallout from Russia's invasion of Ukraine in February 2022 which has dramatically shifted the landscape of European defense and security.
