- Market consumption volume increased with a CAGR of 3.2% between 2017 and 2022, to reach a total of 510.8 million kilograms in 2022.

- The performance of the market is forecast to decelerate, with an anticipated CAGR of 4% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$3,438.1 million by the end of 2027.
