- The UK Fragrances market had total revenues of \$2,360.6 million in 2022, representing a compound annual growth rate (CAGR) of 0.1% between 2017 and 2022.
- Market consumption volumes declined with a CAGR of -2.5% between 2017 and 2022, to reach a total of 82 million units in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 2.4% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$2,662.1 million by the end of 2027.
