- The systems & ordnance segment accounted for market's the largest proportion in 2022, with total revenues of \$2.1 billion, equivalent to 60.1% of the market's overall value.

- According to in-house research, the defense budget inclusive of US aid is anticipated to increase from \$24.4 billion in 2024 to \$27.5 billion in 2028 reflecting a CAGR of 3% over the forecast period. This will drive the market growth over the forecast period.
