- The Israeli telecommunication services market had total revenues of \$4.2 billion in 2022, representing a compound annual growth rate (CAGR) of 1.7% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 1.4% between 2017 and 2022, to reach a total of 17.0 million total subscriptions in 2022.
- Israel's share of the telecommunication services market stood in the Middle East region stood at 12.7% in 2022. The growth in 2022 is attributed to the growing proportion of internet users and the increasing mobile subscriber penetration rate.
