- The systems & ordnance segment accounted for the market's largest proportion in 2022, with total revenues of \$1.4 billion, equivalent to 41.1% of the market's overall value.
- Turkey and Greece have been engaged in a long dispute over territory in Cyprus. Also, the country's long-running battle with the PKK, a terrorist organization, is another cause of increasing defense spending, therefore driving market growth.
