Both unbranded generics and branded generics are included in our market scope. However, off-patent drugs that continue to be offered by the original manufacturer under the original name, and which form part of the 'generic-eligible' market, are not included. The market value is evaluated at ex-factory prices.
- The Asia-Pacific generics market had total revenues of \$162.4 billion in 2022, representing a compound annual growth rate (CAGR) of 11.2% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 2.2% between 2017 and 2022, to reach a total of 62.4% in 2022.
- Factors such as accelerating healthcare costs, rising expiration of patents for branded medicines, growing first generic drug approvals, increasing cardiovascular and infectious diseases, and a growing number of generic manufacturers are driving the generics market.
