- The US jewelry & watches market generated total revenues of \$138,339.0 million in 2021, representing a compound annual growth rate (CAGR) of 3.1% between 2017 and 2021.
- The jewelry & watches segment was the market's most lucrative in 2021, with total revenues of \$97,433.0 million, equivalent to 70.4% of the market's overall value.
- In 2021, demand growth was due to the lack of competition for discretionary spending coupled with temporary restriction in spending on travel and entertainment.
