- The South Korean internet access market had total revenues of \$3.9 billion in 2022, representing a compound annual growth rate (CAGR) of -3.1% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 1.2% between 2017 and 2022, to reach a total of 0.04 billion Internet Users in 2022.
- According to in-house research, the proportion of internet users in total population in South Korea was 97.7% in 2022 as compared to 97.5% in 2021. The government now depends more heavily on the internet to spread information and raise public awareness. The internet access market is anticipated to be driven by technological advancements and improvements in bandwidth throughout the forecasted period.
