- The accessories segment was the market's most lucrative in 2021, with total revenues of \$4,861.7 million, equivalent to 54.8% of the market's overall value.
- In 2020, the market experienced negative growth owing to economic uncertainty, low demand, and diverted spending on essential goods. In 2021, the market continues to decline further.
