- The Internet access market includes all Internet service revenues collected to provide narrowband and broadband Internet access through consumer and business channels. All revenues calculated are retail revenues that are exclusive of taxes. Only fixed communication is included, and mobile phone connections are not considered.
- The Italian internet access market had total revenues of \$5.7 billion in 2022, representing a compound annual growth rate (CAGR) of 2.3% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 2% between 2017 and 2022, to reach a total of 0.04 billion Internet Users in 2022.
- Comparatively to the rest of the EU, Italy has comparatively low internet penetration rates. Following an EU directive, some Russian state-owned websites were blocked in March 2022 by Italian internet service providers (ISPs) and telecom companies.
