- The UK internet access market had total revenues of \$14.8 billion in 2022, representing a compound annual growth rate (CAGR) of 0.6% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 0.7% between 2017 and 2022, to reach a total of 0.06 billion Internet Users in 2022.
- According to a survey by Ofcom, there are still about 1.5 million homes without internet connectivity in the UK. The Russian-Ukrainian War caused internet connections to be disrupted. Communications services were significantly impacted by the storms.
