- Within the real estate industry, China is the leading country among the top 5 emerging nations, with market revenues of \$1,498,730.2 million in 2022. This was followed by India and Brazil with a value of \$450,585.1 and \$123,032.0 million, respectively.
- China is expected to lead the real estate industry in the top five emerging nations, with a value of \$1,766,747.9 million in 2027, followed by India and Brazil with expected values of \$598,013.7 and \$162,634.5 million, respectively.
