Within the paper & paperboard industry, the US is the leading country among the NAFTA bloc, with market revenues of \$71,145.6 million in 2022. This was followed by Mexico and Canada, with a value of \$9,871.9 and \$7,313.3 million, respectively.
The US is expected to lead the paper & paperboard industry in the NAFTA bloc, with a value of \$76,614.6 million in 2027, followed by Mexico and Canada with expected values of \$11,716.0 and \$7,582.1 million, respectively.
