The top 5 emerging countries are expected to reach a value of \$204,109.3 million in 2027, with a CAGR of 4.4% over the 2022-27 period.
- Within the paper & paperboard industry, China is the leading country among the top 5 emerging nations, with market revenues of \$128,336.6 million in 2022. This was followed by India and Brazil with a value of \$13,886.0 and \$10,279.4 million, respectively.
- China is expected to lead the paper & paperboard industry in the top five emerging nations, with a value of \$163,073.3 million in 2027, followed by India and Mexico with expected values of \$15,778.3 and \$11,716.0 million, respectively.
