Volumes represent the consumption of paper and paperboard in tonnes, and values are calculated using average annual selling price of paper and paperboard per tonne multiplied by consumption volumes.
- All market data and forecasts are represented in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2022 annual average exchange rates.
- The global paper & paperboard market had total revenues of \$403,404.5 million in 2022, representing a compound annual growth rate (CAGR) of 1.6% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 0.9% between 2017 and 2022, reaching a total of 416,965.5 thousand tons in 2022.
- The growth of the paper & paperboard market in recent years can be partly attributed to the rise of the e-commerce industry. For instance, according to in-house research, the global e-commerce industry stood at \$6,259.5 billion in 2022, an increase from \$5,496.2 billion in the previous year.
