- Within the footwear retail industry, China is the leading country among the BRIC nations with market revenues of \$70,530.4 million in 2022. This was followed by India, Brazil and Russia with a value of \$10,911.9, \$5,956.3, and \$4,728.3 million, respectively.
- China is expected to lead the footwear retail industry in the BRIC nations with a value of \$94,804.7 million in 2027, followed by India, Brazil, Russia with expected values of \$18,720.7, \$7,464.2 and \$4,676.8 million, respectively.
