In the case of motels, this includes off-street parking facilities, but not necessarily meal services. The industry is detailed in both value and volume terms.
- The Industry value consists of the total revenue generated by (a) rent that a guest pays for an occupied room and (b) other revenues, including revenue from food and beverages, telecommunications, health and leisure operations, and car rentals.
- Industry volume consists of the number of establishments in a given country that provide paid lodging and full guest services.
- All market data and forecasts are represented in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2022 annual average exchange rates.
- The global hotels & motels industry had total revenues of \$774.3 billion in 2022, representing a negative compound annual growth rate (CAGR) of 2% between 2017 and 2022.
- Industry consumption volume increased with a CAGR of 1% between 2017 and 2022, to reach a total of 398,611 establishments in 2022.
- In the global hotels & motels industry, Europe is the largest region, accounting for 35.5%, followed by North America (32.7%), Asia-Pacific (24.7%), the Middle East (3.7%), and South America (2.7%) in 2022.
