The hotels & motels industry within the NAFTA countries had a total market value of \$253,029.0 million in 2022. The US was the fastest growing country, with a CAGR of -0.5% over the 2018-22 period.
- Within the hotels & motels industry, the US is the leading country among the NAFTA bloc, with market revenues of \$211,638.0 million in 2022. This was followed by Canada and Mexico, with a value of \$21,432.0 and \$19,959.0 million, respectively.
- The US is expected to lead the hotels & motels industry in the NAFTA bloc, with a value of \$285,165.0 million in 2027, followed by Canada and Mexico with expected values of \$34,638.0 and \$28,872.0 million, respectively.
