Bolivia has managed to protect itself to a large extent from inflation by continuing to have a fixed exchange rate against the dollar. Besides the fixed exchange rate, Bolivia's subsidies for key products have also helped keep inflation low. However, there has been challenges for the economy in 2023, with sharp falls in foreign currency reserves and dwindling exports. With this background, dairy in Bolivia is expected to register moderate current value growth, but minimal volume growth.
