High unit prices, combined with a slowly recovering foodservice industry, following the easing of pandemic restrictions, had a negative impact on consumption. With the category comprising mainly products that are considered discretionary or luxury items, it was especially susceptible to the erosion of purchasing power, which led Slovaks to prioritise spending on stapl...
