COLOCATION DEMAND AND SUPPLY HIGHLIGHTS

- The Colombia data center colocation market was valued at USD 60 million in 2022 and is expected to reach USD 236 million by 2028, growing at a CAGR of 25.64%.

-[Colombia is one of the emerging locations in Latin America regarding capacity addition. Several factors are leading to the market's growth, such as adopting technologies such as AI, IoT, and big data, steadily growing demand for cloud storage, a shift from on-premise to colocation, and others.

- Colombia is home to around 19 colocation data centers operated by local and foreign operators such as GlobeNet Telecom, ODATA (Aligned Data Centers), Equinix, Grupo Gtd, and Grupo ZFB.

_Several significant operators have entered the market under construction/announced/planned projects, such as Ascenty, Scala
Data Centers, and others.

- Growing opportunities in the market have also led foreign investors to enter the market by acquiring data centers. For instance, KIO Networks entered the market in 2023 by developing one data center in Bogota from Grupo ZFB.

-[The market is witnessing steady growth in connectivity via submarine cables with upcoming submarine cables such as Carnival Submarine Network-1, which will be ready for service in 2025, and the Caribbean Express line, which will be prepared for service in 2026.
