The Kuwait data center market is expected to grow at a CAGR of 10.03% during the forecast period.

KEY HIGHLIGHTS

- Kuwait City is the most preferred location in the region for developing data centers due to their proximity to end-users.
- Among the Gulf Cooperation Council (GCC), Kuwait ranked 2nd regarding the availability of the 5G telecommunications network, with a rate of 33.6%. Ooredoo Kuwait and Zain Kuwait are telecom operators working to deploy commercial 5G services in the region.
- The Kuwait data center market has around four existing submarine cables connecting the Middle East, Africa, and Europe. 2Africa is the upcoming submarine cable connecting Kuwait to other Middle Eastern, African, European, and Asian countries.
- The Kuwait data center industry has the presence of cloud service providers such as Amazon Web Services, Microsoft, Oracle, and Google. For instance, in January 2023, Google planned to develop a new cloud region that provides services to local customers, including the Government of Kuwait and Alshaya Group.
- In Kuwait, Microsoft's ecosystem and cloud-based services enable technology adoption with large-scale investments, generating around 13,000 new jobs in the country by 2024.
