#### Summary

It is divided into five segments, these being hydroelectricity, wind energy, solar, biomass, and geothermal. The volume of the market is calculated as the net volume of electricity produced through renewable means. The value of the industry is the amount of electricity produced multiplied by the wholesale price data for electricity generation.
- The Peruvian renewable energy market had total revenues of \$0.9 billion in 2022, representing a compound annual growth rate (CAGR) of 3.1% between 2017 and 2022.
- Market production volume increased with a CAGR of 2.1% between 2017 and 2022, to reach a total of 34,727.6 GWh in 2022.
- Peru captured a share of 0.6% of the American renewable energy market, in 2022.
