- Market consumption volume increased with a CAGR of 3.9% between 2017 and 2022, reaching a total of 138,174.6 thousand tons in 2022.
- The growth of the paper & paperboard market in recent years can be partly attributed to the rise of the e-commerce industry. For instance, according to in-house research, the global e-commerce industry stood at \$6,259.5 billion in 2022, an increase from \$5,496.2 billion in the previous year.
