- The Japanese cloud computing industry had total revenues of \$17.7 billion in 2022, representing a compound annual growth rate (CAGR) of 14.7% between 2017 and 2022.
- The SaaS segment accounted for the industry's largest proportion in 2022, with total revenues of \$10.1 billion, equivalent to 57.1% of the industry's overall value.
- The industry growth is attributed to the favourable features of cloud computing such as virtualization and automation technologies, which makes service delivery through internet easy, affordable, fast, reliable, safe, and flexible.
