Volumes represent the consumption of paper and paperboard in tonnes, and values are calculated using average annual selling price of paper and paperboard per tonne multiplied by consumption volumes.
- The South Korean paper & paperboard market had total revenues of \$9,216.8 million in 2022, representing a compound annual growth rate (CAGR) of 0.6% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 0.5% between 2017 and 2022, reaching a total of 9,549.2 thousand tons in 2022.
- According to the Bank of Korea, in November 2022, the Composite Consumer Sentiment Index (CCSI) of South Korea stood at 86.5, a decrease of 2.3 points over the previous month.
