- The French life insurance market had total gross written premiums of \$176.2 billion in 2022, representing a compound annual growth rate (CAGR) of 1.6% between 2017 and 2022.
- The Life Insurance segment accounted for market's the largest proportion in 2022, with total gross written premiums of \$149.4 billion, equivalent to 84.8% of the market's overall value.
- The French life insurance market showed significant growth in 2021, after a steep decline in 2020 due to COVID-19. However, the market fell also fell in 2022 with the declining consumer confidence as is seen in September of 2022. The performance of the market is forecast to decelerate, with an anticipated CAGR of 1.3% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$187.8billion by the end of 2027.
