- The renewable energy market consists of the net generation of electricity through renewable sources. It is divided into five segments, these being hydroelectricity, wind energy, solar, biomass, and geothermal. The volume of the market is calculated as the net volume of electricity produced through renewable means. The value of the industry is the amount of electricity produced multiplied by the wholesale price data for electricity generation.
- The Italian renewable energy market had total revenues of \$17.7 billion in 2022, representing a compound annual growth rate (CAGR) of 7.1% between 2017 and 2022.
- Market production volume increased with a CAGR of 4.3% between 2017 and 2022, to reach a total of 123,440.8 GWh in 2022.
- Italy, given its location, has a strong resource base that allows it to partially replace the natural gas-generated electricity it now uses with renewable energy. According to the International Trade Administration (ITA), Italy had 58 GW of installed renewable energy.
