The value of the industry is the amount of electricity produced multiplied by the wholesale price data for electricity generation.
- The Norwegian renewable energy market had total revenues of \$7.1 billion in 2022, representing a compound annual growth rate (CAGR) of 5.7% between 2017 and 2022.
- Market production volume increased with a CAGR of 1.6% between 2017 and 2022, to reach a total of 156,784.9 GWh in 2022.
- Norway captured a share of 5.5% of the European renewable energy market, in 2022.
