The value of the industry is the amount of electricity produced multiplied by the wholesale price data for electricity generation.
- The Portuguese renewable energy market had total revenues of \$1.9 billion in 2022, representing a compound annual growth rate (CAGR) of 9.3% between 2017 and 2022.
- Market production volume increased with a CAGR of 9.2% between 2017 and 2022, to reach a total of 34,056.0 GWh in 2022.
- Portugal captured a share of 1.5% of the European renewable energy market, in 2022.
