Volumes represent the consumption of paper and paperboard in tonnes, and values are calculated using average annual selling price of paper and paperboard per tonne multiplied by consumption volumes.
- The Asia-Pacific paper & paperboard market had total revenues of \$207,503.5 million in 2022, representing a compound annual growth rate (CAGR) of 1.9% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 2.1% between 2017 and 2022, reaching a total of 222,125.9 thousand tons in 2022.
- The growth of the paper & paperboard market in recent years can be partly attributed to the rise of the e-commerce industry. For instance, according to in-house research, the global e-commerce industry stood at \$6,259.5 billion in 2022, an increase from \$5,496.2 billion in the previous year.
