Volumes represent the consumption of paper and paperboard in tonnes, and values are calculated using average annual selling price of paper and paperboard per tonne multiplied by consumption volumes.
- The European paper & paperboard market had total revenues of \$83,962.4 million in 2022, representing a compound annual growth rate (CAGR) of 1.7% between 2017 and 2022.
- Market consumption volumes declined with a negative CAGR of 0.2% between 2017 and 2022, reaching a total of 88,867.2 thousand tons in 2022.
- The growth of the paper & paperboard market in recent years can be partly attributed to the rise of the e-commerce industry. For instance, according to in-house research, the European e-commerce market value stood at \$1,182.1 billion in 2022, an increase from \$1,048.7 billion in the previous year.
