Mexico was the fastest growing country, with a CAGR of 9.7% over the 2018-22 period.
- Within the government spendings industry, the US is the leading country among the NAFTA bloc, with market revenues of \$9,032.0 billion in 2022. This was followed by Mexico and Canada, with a value of \$428.0 and \$289.0 billion, respectively.
- The US is expected to lead the government spendings industry in the NAFTA bloc, with a value of \$10,589.3 billion in 2027, followed by Mexico and Canada with expected values of \$625.9 and \$315.8 billion, respectively.
