- Within the government spendings industry, China is the leading country among the BRIC nations with market revenues of \$3,872.4 billion in 2022. This was followed by Brazil, India and Russia with a value of \$739.3, \$543.6, and \$359.7 billion, respectively.
- China is expected to lead the government spendings industry in the BRIC nations with a value of \$4,727.5 billion in 2027, followed by Brazil, India, Russia with expected values of \$1,402.0, \$890.4 and \$520.2 billion, respectively.
