The top 5 emerging countries are expected to reach a value of \$7,803.1 billion in 2027, with a CAGR of 6.5% over the 2022-27 period.
- Within the government spendings industry, China is the leading country among the top 5 emerging nations, with market revenues of \$3,872.4 billion in 2022. This was followed by Brazil and India with a value of \$739.3 and \$543.6 billion, respectively.
- China is expected to lead the government spendings industry in the top five emerging nations, with a value of \$4,727.5 billion in 2027, followed by Brazil and India with expected values of \$1,402.0 and \$890.4 billion, respectively.
