- Within the prepared meals industry, the US is the leading country among the NAFTA bloc, with market revenues of \$47,287.6 million in 2022. This was followed by Canada and Mexico, with a value of \$4,390.9 and \$473.4 million, respectively.
- The US is expected to lead the prepared meals industry in the NAFTA bloc, with a value of \$54,001.5 million in 2027, followed by Canada and Mexico with expected values of \$5,038.0 and \$591.3 million, respectively.
