The top 5 emerging countries are expected to reach a value of \$13,129.0 million in 2027, with a CAGR of 3.7% over the 2022-27 period.
- Within the prepared meals industry, China is the leading country among the top 5 emerging nations, with market revenues of \$8,683.7 million in 2022. This was followed by Brazil and South Africa with a value of \$950.9 and \$686.1 million, respectively.
- China is expected to lead the prepared meals industry in the top five emerging nations, with a value of \$10,195.1 million in 2027, followed by Brazil and South Africa with expected values of \$1,098.0 and \$982.4 million, respectively.
