- These countries contributed \$1,118,450.1 million to the global foodservice industry in 2022, with a compound annual growth rate (CAGR) of -1.1% between 2007 and 2011. The top 5 emerging countries are expected to reach a value of \$1,581,212.2 million in 2027, with a CAGR of 7.2% over the 2022-27 period.
- Within the foodservice industry, China is the leading country among the top 5 emerging nations, with market revenues of \$786,696.7 million in 2022. This was followed by India and Brazil with a value of \$149,926.2 and \$84,182.1 million, respectively.
- China is expected to lead the foodservice industry in the top five emerging nations, with a value of \$1,074,660.4 million in 2027, followed by India and Brazil with expected values of \$219,967.3 and \$135,458.0 million, respectively.
