The US was the fastest growing country, with a CAGR of 4.5% over the 2018-22 period.
Within the apparel & non-apparel manufacturing industry, the US is the leading country among the NAFTA bloc, with market revenues of \$466,933.1 million in 2022. This was followed by Canada and Mexico, with a value of \$31,849.3 and \$19,800.6 million, respectively.

- The US is expected to lead the apparel & non-apparel manufacturing industry in the NAFTA bloc, with a value of \$541,966.8 million in 2027, followed by Canada and Mexico with expected values of \$39,690.5 and \$27,048.2 million, respectively.
