- Among the G8 nations, the US is the leading country in the bpo services industry, with market revenues of \$103,668.4 million in 2022. This was followed by Japan and the UK, with a value of \$17,586.7 and \$13,473.6 million, respectively.
- The US is expected to lead the bpo services industry in the G8 nations with a value of \$116,153.6 million in 2027, followed by Japan and the UK with expected values of \$24,345.5 and \$17,706.1 million, respectively.
