The Canada bone graft and substitute market is expected to project a CAGR of 6.49% during the forecast period, 2023-2030. The aging population in Canada has led to an increased demand for bone graft and substitute procedures, as older individuals are more susceptible to bone-related conditions. Osteoarthritis was the leading diagnosis for primary hip and knee replacement patients, accounting for 72.5% and 99.4%, respectively. Hip and knee replacement surgeries continue to be among the most common medical procedures in Canada, resulting in significant annual healthcare costs. This trend could potentially benefit the bone graft and substitute market, contributing to its growth.
