It also includes all sportswear and fancy dress.
- The South African apparel retail industry had total revenues of \$9.7 billion in 2022, representing a compound annual growth rate (CAGR) of 5.6% between 2017 and 2022.
- The womenswear segment accounted for the industry's largest proportion in 2022, with total revenues of \$4.3 billion, equivalent to 44% of the industry's overall value.
- South Africa's success is largely attributed to the country's adoption of a retail, clothing, textile, footwear, and leather (R-CTFL) master plan, and government initiatives to revive the flagging domestic textiles industry through the "Buy Local" campaign.
