- The South African foodservice industry had total revenues of \$33.2 billion in 2022, representing a compound annual growth rate (CAGR) of 3.1% between 2017 and 2022.
- Industry consumption volume increased with a CAGR of 2.9% between 2017 and 2022, to reach a total of 7.9 billion transactions in 2022.
- South African food service industry is dynamic and diverse, reflecting the nation's multicultural population, culinary heritage, and shifting consumer tastes
