- The South African Prepared Meals market had total revenues of \$686.1 million in 2022, representing a compound annual growth rate (CAGR) of 9.3% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 5% between 2017 and 2022, to reach a total of 123.2 million kilograms in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 7.4% for the five-year period 2022 2027, which is expected to drive the market to a value of \$982.4 million by the end of 2027.
