- The meat market consists of the retail sales of ambient meat, chilled raw packaged meat - processed, chilled raw packaged meat - whole cuts, cooked meats - counter, cooked meats - packaged, fresh meat (counter) and frozen meat. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2022 exchange rates.
- The Canadian Meat market had total revenues of \$20,189.0 million in 2022, representing a compound annual growth rate (CAGR) of 4.5% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 1.4% between 2017 and 2022, to reach a total of 1,451.3 million kilogram in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 2.1% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$22,441.6 million by the end of 2027.
